MANY FAMILIES ENTERING OUR HOMELESS SHELTER AT ST. BARNABAS MISSION HAVE ALREADY SPENT MONTHS OR YEARS SLEEPING ON COUCHES AND FLOORS OR IN DANGEROUSLY SUBSTANDARD HOUSING. OTHERS ARE FLEEING ABUSE. A SAFE SHELTER TO STAY IS THE CRITICAL FIRST STEP TO STABILITY, BUT WE DON'T STOP THERE. WE PROVIDE PHYSICAL AND MENTAL HEALTH SCREENINGS AND ASSISTANCE CONNECTING FAMILIES TO CARE.
